

DSWD DROMIC Report on the Fire Incident in Brgy. Banica, Roxas City, Capiz

02 July 2025, 6AM

I. Situation Overview

On 26 June 2025 at around 7:34 PM, a fire broke out in Brgy. Banica, Roxas City, Capiz. The Bureau of Fire Protection promptly responded to the scene and was able to extinguish the fire by 8:00 PM. The fire damaged a business establishment and affected two families who relied on it for their livelihood.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) in Region VI, in coordination with the Local Government Unit (LGU) of Roxas City, provided relief assistance to address the immediate needs of the affected families.
