

## DSWD DROMIC Report on the Fire Incident in Brgy. Bari, Mangaldan, Pangasinan 06 July 2025, 6AM

### I. Situation Overview

On 07 June 2025 at around 7:14 AM, a fire incident occurred in Brgy. Bari, Mangaldan, Pangasinan.

**One (1) family or three (3) persons** are temporarily staying with their relatives (see Annex B).

### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Bari, Mangaldan, Pangasinan** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱35,857.35** worth of assistance was provided to the affected family; of which, **₱20,857.35** from **DSWD** and **₱15,000.00** from the **Local Government Unit (LGU)** (see Annex D).
