

DSWD DROMIC Report on the Fire Incident in Brgy. Cabagnaan, La Castellana, Negros Occidental

15 July 2025, 6PM

I. Situation Overview

On 04 July 2025 at around 5:00 AM, a fire broke out at Sitio Old Fabrica, Brgy. Cabagnaan, La Castellana, Negros Occidental. A residential structure was completely destroyed, displacing a family who has since sought temporary shelter with relatives.

In response, the Department of Social Welfare and Development, through its Field Office (FO) in Region VI, in coordination with the Local Government Unit (LGU) of La Castellana, Negros Occidental, provided relief assistance to address the immediate needs of the affected family.

II. Status of Affected Areas and Population

One (1) family or six (6) persons were affected in **Brgy. Cabagnaan, La Castellana, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or six (6) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Cabagnaan, La Castellana, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱9,268.00** worth of assistance was provided to the affected family; of which, **₱4,268.00** from **DSWD** and **₱5,000.00** from the **LGU** (see Annex D).
