

## **DSWD DROMIC Report on the Fire Incident in Brgy. Calubang, Ilog, Negros Occidental**

16 July 2025, 6PM

### **I. Situation Overview**

On 13 July 2025 at around 8:30 AM, a fire broke out at Purok Mabini, Brgy. Calubang, Ilog, Negros Occidental. A residential structure was completely destroyed, displacing a family who has since sought temporary shelter with relatives. No injuries or casualties were reported.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) in Region VI, in coordination with the Local Government Unit (LGU) of Ilog, Negros Occidental, provided relief assistance to address the immediate needs of the affected family.

**One (1) family or three (3) persons** were affected in **Brgy. Calubang, Ilog, Negros Occidental** (see Annex A).

**One (1) family or three (3) persons** temporarily stayed with their relatives (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Brgy. Calubang, Ilog, Negros Occidental** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱4,600.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
