I. Situation Overview

On 26 May 2025 at around 12:00 AM, a fire incident occurred at Zone 7, Brgy. Coldit, Asingan, Pangasinan.

A total of **₱28,247.50** worth of assistance was provided to the affected person, of which, **₱17,467.50** from **DSWD** and **₱10,600.00** from the **Local Government Unit (LGU)** (see Annex D).
