

DSWD DROMIC Report on the Fire Incident in Brgy. Garrita, Bani, Pangasinan

11 July 2025, 6PM

I. Situation Overview

On 27 April 2025 at around 4:00 PM, a fire incident occurred at #48, Zone 1, Brgy. Garrita, Bani, Pangasinan. The fire was declared out at around 6:11 AM.

One (1) family or five (5) persons temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was partially damaged in **Brgy. Garrita, Bani, Pangasinan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱22,099.73** worth of assistance was provided to the affected family; of which, **₱17,099.73** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
