I. Situation Overview

On 14 June 2025 at around 3:26 PM, a fire incident occurred in Brgy. Lira, San Juan, llocos Sur.

A total of three (3) families or five (5) persons were affected in Brgy. Lira, San Juan, Ilocos Sur (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of three (3) families or five (5) persons sought temporary shelter at the **Municipal Evacuation Center** in **San Juan**, **Ilocos Sur** (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Lira, San Juan, Ilocos Sur** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱55,998.73** worth of assistance was provided to the affected families; of which, **₱48,998.73** from **DSWD** and **₱7,000.00** from the **LGU** (see Annex D).
