

## **DSWD DROMIC Report on the Fire Incident in Brgy. Makiang, Siocon, Zamboanga del Norte**

13 July 2025, 6AM

### **I. Situation Overview**

On 20 June 2025 at around 4:58 PM, a fire occurred in Brgy. Makiang, Siocon, Zamboanga del Norte. The fire was declared out at around 5:30 PM. Due to the incident, four (4) individuals were affected and caused significant damage to their house.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office FO IX, in close coordination with the Local Government Unit (LGU) of Siocon, Zamboanga del Norte, immediately provided food and non-food items (FNIs) to address the immediate needs of the affected individuals.

**One (1) family or four (4) persons** temporarily stayed with their friends (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Brgy. Makiang, Siocon, Zamboanga del Norte** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱7,401.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
