

DSWD DROMIC Report on the Fire Incident in Brgy. Maybato Sur, San Jose, Antique

15 July 2025, 6PM

I. Situation Overview

On 08 July 2025 at around 9:00 PM, a fire broke out in Brgy. Maybato Sur, San Jose, Antique. Two residential structures were damaged, displacing two families who have since sought temporary shelter with relatives.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) in Region VI, in coordination with the Local Government Unit (LGU) of San Jose, Antique, provided relief assistance to address the immediate needs of the affected families.

II. Status of Affected Areas and Population

A total of **two (2) families** or **seven (7) persons** were affected in **Brgy. Maybato Sur, San Jose, Antique** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **two (2) families** or **seven (7) persons** temporarily stayed with their relatives in **Brgy. Maybato Sur, San Jose, Antique (**see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were damaged; of which, **one (1)** was **totally damaged** and **one (1)** was **partially damaged** in **Brgy. Maybato Sur, San Jose, Antique** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P8,809.00** worth of assistance was provided to the affected families; of which, **P1,244.00** from **DSWD** and **P7,565.00** from the **LGU** (see Annex D).
