

DSWD DROMIC Report on the Fire Incident in Brgy. Oringao, City of Kabankalan, Negros Occidental

02 July 2025, 6AM

I. Situation Overview

On 18 June 2025 at around 3:30 PM, a fire broke out in Brgy. Oringao, City of Kabankalan, Negros Occidental. The fire damaged a residential structure and displaced a family, who had sought temporary shelter with relatives.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) in Region VI, in coordination with the Local Government Unit (LGU) of City of Kabankalan, provided relief assistance to address the immediate needs of the affected family.

II. Status of Affected Areas and Population

One (1) family or five (5) persons were affected in Brgy. Oringao, City of Kabankalan, Negros Occidental (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or five (5) persons temporarily stayed with their relatives (see Annex B). They have since returned home after completing repairs to their house.

IV. Damaged Houses

One (1) house was partially damaged in Brgy. Oringao, City of Kabankalan, Negros Occidental (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱5,988.00 worth of assistance was provided to the affected family; of which, ₱4,588.00 from DSWD and ₱1,400.00 from the LGU (see Annex D).
