I. Situation Overview

On 26 June 2025 at around 9:50 AM, a fire incident occurred at Zamora St., Brgy. Poblacion, Nabas, Aklan. The fire was declared out at around 10:13 AM.

A total of **four (4) families** or **10 persons** were affected in **Brgy. Poblacion, Nabas, Aklan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **four (4) families** or **10 persons** temporarily stayed with their relatives or friends in **Brgy. Poblacion, Nabas, Aklan** (see Annex B).

IV. Damaged Houses

One (1) house was partially damaged in Brgy. Poblacion, Nabas, Aklan (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱75,512.00 worth of assistance was provided to the affected families; of which, ₱25,512.00 from DSWD and ₱50,000.00 from the Local Government Unit (LGU) (see Annex D).
