

DSWD DROMIC Report on the Fire Incident in Brgy. Poblacion Oeste, Dagupan City, Pangasinan

14 July 2025, 6AM

I. Situation Overview

On 06 June 2025 at around 1:18 PM, a fire incident occurred in Brgy. Poblacion Oeste, Dagupan City, Pangasinan. Due to the incident, 10 individuals were affected and caused significant damage to their houses.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) I, together with the Local Government Unit (LGU) of Dagupan City, Pangasinan, immediately provided food and non-food items (FNIs) and financial assistance (FA) to address the immediate needs of the affected individuals.

II. Status of Affected Areas and Population

A total of three (3) families or 10 persons were affected in Brgy. Poblacion Oeste, Dagupan City, Pangasinan (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **three (3) families** or **10 persons** are temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

A total of three (3) houses were damaged; of which, two (2) are totally damaged and one (1) is partially damaged in Brgy. Poblacion Oeste, Dagupan City, Pangasinan (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱60,748.05 worth of assistance was provided to the affected families; of which, ₱53,488.05 from DSWD and ₱7,260.00 from the LGU (see Annex D).
