

DSWD DROMIC Report on the Fire Incident in Brgy. Proper Bagay, Daanbantayan, Cebu

10 July 2025, 6AM

I. Situation Overview

On 06 December 2024 at around 2:00 AM, a fire broke out in Brgy. Proper Bagay, Daanbantayan, Cebu. A residential structure was completely destroyed, displacing a family who has since sought temporary shelter with a relative. No injuries or casualties were reported.

II. Status of Affected Areas and Population

One (1) family or **four (4) persons** were affected in **Brgy. Proper Bagay, Daanbantayan, Cebu** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **four (4) persons** are still temporarily staying with a relative while repairing the damage to their home (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Proper Bagay, Daanbantayan, Cebu** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱22,395.50** worth of assistance was provided to the affected family; of which, **₱11,295.50** from **DSWD** and **₱11,100.00** from the **Local Government Unit (LGU)** (see Annex D).
