

DSWD DROMIC Report on the Fire Incident in Brgy. Pughanan, Lambunao, Iloilo

11 July 2025, 6AM

I. Situation Overview

On 28 July 2025 at around 1:00 AM, a fire broke out in Brgy. Pughanan, Lambunao, Iloilo. The Bureau of Fire Protection (BFP) promptly responded to the scene and successfully extinguished the fire by 2:00 AM. A residential structure was completely destroyed, displacing one resident, who has since sought temporary shelter with relatives.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) in Region VI and in coordination with the Local Government Unit (LGU) of Lambunao, Iloilo, immediately provided relief assistance to address the needs of the affected resident.

Outside Evacuation Center

One (1) person temporarily stayed with his relatives in the area (see Annex B).

One (1) house was totally damaged in Brgy. Pughanan, Lambunao, Iloilo (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P5,588.00** worth of assistance was provided by **DSWD** to the affected resident (see Annex D).
