I. Situation Overview

On 07 June 2025 at around 2:16 AM, a fire incident occurred in Brgy. Rizal, Tagudin, Ilocos Sur.

A total of **two (2) houses** were **totally damaged** in **Brgy. Rizal, Tagudin, Ilocos Sur** (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of **₱47,857.96** worth of assistance was provided to the affected families; of which, **₱41,857.96** from **DSWD** and **₱6,000.00** from the **Local Government Unit (LGU)** (see Annex C).
