I. Situation Overview

On 09 April 2025 at around 3:46 PM, a fire incident occurred at Purok 1, Brgy. San Pedro, Alegria, Surigao del Norte. The fire was declared out at around 4:37 PM.

A total of **two (2) houses** were **totally** damaged in **Brgy. San Pedro, Alegria, Surigao del Norte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱25,293.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
