I. Situation Overview

On 16 June 2025 at around 5:30 PM, a fire incident occurred at Purok 4, Brgy. Sugbay, Surigao City, Surigao del Norte.

One (1) house was **totally damaged** in **Brgy. Sugbay, Surigao City, Surigao del Norte** (see Annex D).

V. Cost of Humanitarian Assistance Provided

A total of **₱9,263.50** worth of assistance was provided by **DSWD** to the affected families (see Annex E).
