

DSWD DROMIC Report on the Fire Incident in Brgy. Taculing, Bacolod City

02 July 2025, 6AM

I. Situation Overview

On 30 June 2025 at around 4:16 AM, a fire broke out at City Heights Subdivision, Brgy. Taculing, Bacolod City. The fire completely destroyed a residential structure, displacing a family who have since sought temporary shelter with relatives.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) in Region VI, in coordination with the Local Government Unit of Bacolod City, provided relief assistance to address the immediate needs of the affected family.

II. Status of Affected Areas and Population

One (1) family or two (2) persons were affected in **Brgy. Taculing, Bacolod City** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or two (2) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Taculing, Bacolod City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱8,912.00** worth of assistance was provided to the affected family; of which, **₱4,622.00** from **DSWD** and **₱4,290.00** from the **LGU** (see Annex D).
