

DSWD DROMIC Report on the Fire Incident in Brgy. Talisay, Daanbantayan, Cebu 10 July 2025, 6AM

I. Situation Overview

On 27 January 2024, a fire broke out in Brgy. Talisay, Daanbantayan, Cebu. A residential structure was completely destroyed, displacing one family. The family is currently staying in a makeshift shelter near their property while rebuilding their home.

One (1) family or four (4) persons were affected in **Brgy. Talisay, Daanbantayan, Cebu** (see Annex A).

III. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Talisay, Daanbantayan, Cebu** (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of **₱13,790.00** worth of assistance was provided to the affected family; of which, **₱3,790.00** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex C).
