

# DSWD DROMIC Report on the Fire Incident in Brgy. Buenavista, Pagadian City, Zamboanga del Sur

16 July 2025, 6PM

### I. Situation Overview

On 30 June 2025 at around 12:10 AM, a fire incident occurred at Purok Mahogany, Brgy. Buenavista, Pagadian City, Zamboanga del Sur. A residential structure was completely destroyed, displacing a family who has since sought temporary shelter with relatives or friends. No injuries or casualties were reported.

## II. Status of Affected Areas and Population

**One (1) family** or **six (6) persons** were affected in **Brgy. Buenavista, Pagadian City, Zamboanga del Sur** (see Annex A).

#### III. Status of Displaced Population

Outside Evacuation Center One (1) family or six (6) persons temporarily stayed with their relatives or friends (see Annex B).

#### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Buenavista, Pagadian City, Zamboanga del Sur.** (see Annex C).

#### V. Cost of Humanitarian Assistance Provided

A total of ₱5,365.00 worth of assistance was provided to the affected family; of which, ₱715.00 from DSWD and ₱4,650.00 from the Local Government Unit (LGU) (see Annex D).
