

## DSWD DROMIC Report on the Fire Incident in Brgy. Buenavista, Pagadian City, Zamboanga del Sur

16 July 2025, 6PM

### I. Situation Overview

On 02 July 2025 at around 3:00 PM, a fire broke out at Purok Nazareth 3, Buenavista, Pagadian City, Zamboanga del Sur. A residential structure was damaged, displacing a family who has since sought temporary shelter with relatives or friends.

### II. Status of Affected Areas and Population

**One (1) family or four (4) persons** were affected in **Brgy. Buenavista, Pagadian City, Zamboanga del Sur** (see Annex A).

### III. Status of Displaced Population

#### Outside Evacuation Center

**One (1) family or four (4) persons** temporarily stayed with their relatives or friends in **Brgy. Buenavista, Pagadian City, Zamboanga del Sur** (see Annex B).

### IV. Damaged Houses

**One (1) house** was **partially** damaged in **Brgy. Buenavista, Pagadian City, Zamboanga del Sur** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱5,365.00** worth of assistance was provided to the affected family; of which, **₱715.00** from **DSWD** and **₱4,650.00** from the **Local Government Unit (LGU)** (see Annex D).
