

DSWD DROMIC Report on the Strong Wind Incident in Sto. Niño, South Cotabato

15 July 2025, 6PM

I. Situation Overview

On 17 June 2025 at around 6:00 PM, partly cloudy to cloudy skies with isolated rainshowers or thunderstorms may have brought flash floods or landslides during severe thunderstorms caused by easterlies. On the same day, a strong wind incident, caused by easterlies, occurred in four (4) barangays in Sto. Nino, South Cotabato, resulting in damage to multiple residential houses in the area.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) XII, in coordination with the Local Government Unit (LGU) of Sto. Niño, South Cotabato, provided relief assistance to address the immediate needs of the affected families.

II. Status of Affected Areas and Population

A total of **43 families** or **215 persons** were affected in **four (4) barangays** in **Sto. Niño, South Cotabato** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **three (3) families** or **15 persons** are temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **43 houses** were damaged; of which, **three (3)** were **totally damaged** and **40** were **partially damaged** in **Sto. Niño, South Cotabato** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P34,150.96** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
