I. Situation Overview

On 26 December 2024 at around 7:30 PM, a fire incident occurred at Purok 3, Brgy. Camp Allen, Baguio City. The fire was declared out at around 8:00 PM.

A total of ₱13,758.88 worth of assistance was provided to the affected family; of which, ₱3,758.88 from DSWD, and ₱10,000.00 from the Local Government Unit (LGU) (see Annex C).
