

DSWD DROMIC Report #2 on the Fire Incident in Brgy. 97, Tacloban City as of 08 August 2025, 6PM

I. Situation Overview

On 31 July 2025 at around 12:00 PM, a fire incident occurred in Brgy. 97, Tacloban City. Several residential structures were completely destroyed, displacing residents in the area. No injuries or casualties were reported.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) in Region VIII, together with the Local Government Unit (LGU) of Tacloban City, provided relief assistance to address the immediate needs of the affected families.

II. Status of Affected Areas and Population

A total of **22 families** or **80 persons** are affected in **Brgy. 97, Tacloban City** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

There are **22 families** or **80 persons** temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

A total of **22 houses** were damaged; of which, **20** are **totally damaged** and **two (2)** are **partially damaged** in **Brgy. 97, Tacloban City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱378,314.48** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
