

DSWD DROMIC Report on the Fire Incident in Brgy Pag-asa, Sta. Josefa, Agusan del Sur

11 August 2025, 6PM

I. Situation Overview

On 28 June 2025 at around 6:00 AM, a fire incident occurred at Purok 1, Brgy Pag-asa, Sta. Josefa, Agusan del Sur. The fire was declared out at around 7:00 AM. Due to the incident, two (2) individuals were affected and caused significant damage to their house.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) in Caraga, in coordination with the Local Government Unit (LGU) of Sta. Josefa, Agusan del Sur, provided relief assistance to address the immediate needs of the affected family.

One (1) family or two (2) persons were affected in **Brgy Pag-asa, Sta. Josefa, Agusan del Sur** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

One (1) family or two (2) persons sought temporary shelter in the **Pag-asa** evacuation center in **Brgy Pag-asa, Sta. Josefa, Agusan del Sur** (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy Pag-asa, Sta. Josefa, Agusan del Sur** see Annex D).

V. Cost of Humanitarian Assistance Provided

A total of **₱27,146.50** worth of assistance was provided to the affected family composed of **₱12,646.50** from **DSWD** and **₱14,500.00** from the **Local Government Unit (LGU)** (see Annex E).
