

# DSWD DROMIC Report on the Fire Incident in Brgy. 2, Bacolod City

12 August 2025, 6PM

## I. Situation Overview

On 29 July 2025 at around 11:00 AM, a fire incident occurred in Brgy. 2, Bacolod City. Due to the incident, three (3) individuals were affected and caused significant damage to their house.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) in Region VI, in coordination with the Local Government Unit (LGU) of Bacolod City, provided relief assistance to support immediate needs of the affected family.

One (1) family or three (3) persons temporarily stayed with their relatives or friends (see Annex B).

One (1) house was partially damaged in Brgy. 2, Bacolod City (see Annex C).

#### V. Cost of Humanitarian Assistance Provided

A total of ₱8,979.49 worth of assistance was provided to the affected family; of which, ₱4,689.49 from DSWD and ₱4,290.00 from the Local Government Unit (LGU) (see Annex D).
