

# DSWD DROMIC Report on the Fire Incident in Brgy. Camp Downes, Ormoc City, Leyte

09 August 2025, 6PM

#### I. Situation Overview

On 06 May 2025 at around 7:00 PM, a fire incident occurred in Brgy. Camp Downes, Ormoc City, Leyte. Due to the incident, 10 individuals were affected and caused significant damage to three (3) residential houses.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) VIII, in coordination with the Local Government Unit (LGU) of Ormoc City, Leyte, provided food and non - food items (FNIs) as well as financial assistance (FA) to address the immediate needs of the affected families.

A total of three (3) families or 10 persons were affected in Brgy. Camp Downes, Ormoc City, Leyte (see Annex A).

#### **Outside Evacuation Center**

A total of **three (3) families** or **10 persons** temporarily stayed with their relatives or friends (see Annex B).

# IV. Damaged Houses

A total of three (3) houses were totally damaged in Brgy. Camp Downes, Ormoc City, Leyte (see Annex C).

#### V. Cost of Humanitarian Assistance Provided

A total of **P51,654.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
