
DSWD DROMIC Report on the Fire Incident in Brgy. Dagami, Maasin, Iloilo

12 August 2025, 6AM

I. Situation Overview

On 10 July 2025 at approximately 3:00 PM, a fire broke out in Brgy. Dagami, Maasin, Iloilo. The Bureau of Fire Protection (BFP) promptly responded to the scene and was able to extinguish the fire by 4:00 PM. One residential structure was damaged, displacing a family who has since sought temporary shelter with relatives.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) in Region VI, in coordination with the Local Government Unit (LGU) of Maasin, Iloilo, provided relief assistance to address the immediate needs of the affected family.

One (1) family or **seven (7) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Dagami, Maasin, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱7,022.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
