

# DSWD DROMIC Report on the Fire Incident in Brgy. Dayo-an, Tago, Surigao del Sur

08 August 2025, 6PM

#### I. Situation Overview

On 21 July 2025 at around 12:00 PM, a fire incident occurred at Purok Ipil-Ipil, Brgy. Dayo-an, Tago, Surigao del Sur. The fire was declared out at around 12:44 PM.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) Caraga, closely coordinated with the Local Government Unit (LGU) of Tago, Surigao del Sur and provided immediate assistance to the displaced families.

## II. Status of Affected Areas and Population

A total of **five (5) families** or **15 persons** were affected in **Brgy. Dayo-an, Tago, Surigao del Sur** (see Annex A).

### III. Status of Displaced Population

#### **Outside Evacuation Center**

A total of **five (5) families** or **15 persons** temporarily stayed with their relatives or friends (see Annex B).

## IV. Damaged Houses

A total of three (3) houses were damaged; of which, two (2) are totally damaged and one (1) is partially damaged in Brgy. Dayo-an, Tago, Surigao del Sur (see Annex C).

#### V. Cost of Humanitarian Assistance Provided

A total of **P49,789.50** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
