I. Situation Overview

On 03 July 2025 at around 2:00 AM, a fire incident occurred in Brgy. Ipil, Batan, Aklan. The fire was declared out at around 3:00 AM.

One (1) family or three (3) persons were affected in Brgy. Ipil, Batan, Aklan (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or three (3) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Ipil, Batan, Aklan (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱21,378.00 worth of assistance was provided to the affected family; of which, ₱6,378.00 from DSWD and ₱15,000.00 from the Local Government Unit (LGU) (see Annex D).
