

## DSWD DROMIC Report on the Fire Incident in Brgy. Mandalagan, Bacolod City

13 August 2025, 6AM

### I. Situation Overview

On 06 August 2025 at around 9:21 AM, a residential fire broke out in Brgy. Mandalagan, Bacolod City. One residential structure was damaged, displacing a family who sought temporary shelter with their relatives.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) in Region VI, in coordination with the Local Government Unit (LGU) of Bacolod City, provided relief assistance to address the immediate needs of the affected family.

### II. Status of Affected Areas and Population

**One (1) family** or **six (6) persons** were affected in **Brgy. Mandalagan, Bacolod City** (see Annex A).

### III. Status of Displaced Population

#### Outside Evacuation Center

**One (1) family** or **six (6) persons** temporarily stayed with their relatives (see Annex B).

### IV. Damaged Houses

**One (1) house** was **partially damaged** in **Brgy. Mandalagan, Bacolod City** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱10,589.49** worth of assistance was provided to the affected family; of which, **₱6,299.49** from **DSWD** and **₱4,290.00** from the **LGU** (see Annex D).
