

## DSWD DROMIC Report on the Fire Incident in Brgy. Quinlogan, Quezon, Palawan

08 August 2025, 6AM

### I. Situation Overview

On 22 July 2025 at around 1:00 PM, a fire incident occurred at Sitio Kaunlaran, Brgy. Quinlogan, Quezon, Palawan. A residential structure was completely destroyed, displacing the person that lived there.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) in Region MIMAROPA, together with the Local Government Unit (LGU) of Quezon, Palawan, provided relief assistance to address the immediate needs of the affected person.

**One (1) person** was affected in **Brgy. Quinlogan, Quezon, Palawan** (see Annex A).

#### Outside Evacuation Center

**One (1) person** temporarily stayed with relatives (see Annex B).

### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Quinlogan, Quezon, Palawan** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱12,584.86** worth of assistance was provided to the affected person; of which, **₱2,584.86** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
