

DSWD DROMIC Report on the Flooding Incident in Pototan, Iloilo

07 August 2025, 6AM

I. Situation Overview

Issued on 22 June 2025 at 4:00 AM, partly cloudy to cloudy skies with isolated rainshowers or thunderstorms caused by localized thunderstorms may have brought possible flash floods or landslides during severe thunderstorms for the rest of the country.

On the same day at around 6:15 AM, several barangays in the municipalities of Pototan, Iloilo experienced flooding due to localized thunderstorms.
