

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Colambugon, Maramag, Bukidnon

03 December 2025, 6AM

I. Situation Overview

On 22 September 2025 at around 2:00 PM, a fire occurred at Purok 4, Brgy. Colambugon, Maramag, Bukidnon. Two (2) houses were completely destroyed, displacing eight (8) individuals who are currently staying with their relatives. No injuries or casualties were reported.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) X, together with the Local Government Unit (LGU) of Maramag, Bukidnon, provided food and non - food items to address the immediate needs of the affected families.

II. Status of Affected Areas and Population

A total of **two (2) families** or **eight (8) persons** are affected in **Brgy. Colambugon, Maramag, Bukidnon** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

There are **two (2) families** or **eight (8) persons** temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were **totally damaged** in **Brgy. Colambugon, Maramag, Bukidnon** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱14,376.00** worth of assistance was provided to the affected families; of which, **₱7,376.00** from **DSWD** and **₱7,000.00** from the **Local Government Unit (LGU)** (see Annex D).
